

BYLAW NO. 2016-10

**A BYLAW OF THE TOWN OF LAMPMAN, IN THE PROVINCE
OF SASKATCHEWAN, TO AUTHORIZE A SPECIAL
ASSESSMENT WITH RESPECT TO THE UNDERTAKING OF
CURBING ALONG THE 400 BLOCK OF 1ST AVENUE EAST
AS A LOCAL IMPROVEMENT**

The Council of the Town of Lampman, in the Province of Saskatchewan, enacts as follows:

1. A special assessment is authorized and shall be charged against all lands shown in the special assessment roll (identified as Schedule "A", attached to and forming part of this Bylaw) as follows:
 - (a) On a prepayment basis, \$203.89 per metre shall be assessed.
 - (b) Where the charges are not prepaid, annual installments in the amount of \$49.73 per metre shall be added to and form part of, the taxes on the said lands in each year for a period of five (5) years commencing in the year 2016.
2. The amounts fixed in 1 (b) above, include interest at the rate of seven percent (7%) per annum.
3. This Bylaw shall come into effect upon final passing thereof.
