**Signing Corridor Policy**

The following shall be used in determining the requirements for signs to be erected in the Town of Lampman Signing Corridor located on the NW quarter of Section 8, Township 5, Range 6, West of the Second Meridian, along Highway No. 361:

1. Application to erect business or non-profit organization sign in signing corridor must be submitted to the Council of the Town of Lampman for approval on the attached Signing Corridor Application which forms part of this Policy.
2. Applications approved by Council may be subject to further approval or further agreement with land owner where the signing corridor is located.
3. The land owner has right of refusal or to charge a fee for each sign.
4. Any fees that may be charged for utilizing the signing corridor shall be collected by the Town of Lampman and forwarded to the land owner or to any other third party as directed by the land owner via a formal agreement.
5. The annual fee for utilizing the signing corridor is one thousand two hundred (\$1,200.00) dollars per sign, for business and non-profit organizations. All funds collected for the signing corridor shall be donated to the Lampman Community Health Care Trust in memory of Clinton Grimes.

6. In accordance with *The Erection of Signs Adjacent to Provincial Highways Regulations*, signs are to be located approximately 22 m from the center line of Highway No. 361 and within the signing corridor boundary as established by Saskatchewan Highways and Infrastructure.
7. In accordance with *The Erection of Signs Adjacent to Provincial Highways Regulations*, the distance between each sign in the corridor shall be approximately 48 m.
8. Authorized signs permitted in signing corridor shall be 1.82 m vertical x 2.43 m horizontal, in size.
9. The back of each sign shall be white in color.
10. Sign supports must be made of 3" iron tubing or 4" x 4" treated wooden posts and shall be painted white.
11. The sign base shall be 1.22 m above ground level.
12. The business or non-profit organization erecting a sign shall be responsible for all costs associated with sign fabrication, erection and maintenance of signs.
13. Signs shall be maintained annually by businesses and non-profit organizations to ensure signs are kept appealing and up-to-date. Signs not maintained adequately will be removed by the Town of Lampman.
14. Illumination of signs in the signing corridor may not be permitted.
