A Bylaw of the Town of Lampman, in the Province of Saskatchewan, being a Bylaw to Establish Criminal Record Checks

1. Subject to section 89.1 of *The Municipalities Act*, candidates must submit a criminal record check on the form in Schedule "A" as attached forming part of this Bylaw, with their nomination paper submitted pursuant to section 67 of *The Local Government Election Act*, 2015.
