A BYLAW OF THE TOWN OF LAMPMAN IN THE PROVINCE OF SASKATCHEWAN
TO AMEND BYLAW NO. 1974-4 of A.D. 1974 - THE ZONING BYLAW

WHEREAS it is deemed expedient and in the public interest to amend the Zoning Bylaw and Map;

NOW THEREFOR, The Council of the Town of Lampman enacts as follows:

1. Bylaw No. 1974-4 is further amended in the manner hereinafter set forth.
2. The Zoning Map as referred to in Section 6 of Bylaw No. 1974-4 is amended to rezone Block "M" Plan No. AE 5675 from C1 - Commercial District to R1 - Residential District.
3. This Bylaw shall come into force and take effect on the date of final approval of the Minister of Municipal Affairs.

Bylaw No. 1977-4, of the Town of Lampman an amendment to the Town's zoning bylaw No. 1974-4, has been approved.

It should be noted that an amendment to the map requires publication of a map of the general area concerned as part of the notice. (Section 65 (2) (a) (ii) of The Planning and Development Act, 1973.) The required map need only be at a small scale just showing the area concerned and a portion of the area surrounding it with the area concerned in the rezoning outlined with a heavy line. An example is enclosed.

It is not necessary to include a copy of the total zoning district map with your submission.
