WATERWORKS RATE POLICY

On September 18, 2024, Council passed a bylaw, (Bylaw No. 2024-08) to fix the rates to be charged for the use and consumption of water and to fix the rates to be charged by way of rent and service charge for the use of the sewer.

Under the waterworks rate policy bylaw, the water rate of \$37.50 for the first 3,000 gallons of water per month and \$5.00 per 1,000 Imperial gallons in excess of 3,000 gallons per month, as adopted under the Water Bylaw, dated September 18, 2024.

The objective of the waterworks rate policy is to work towards waterworks that are self-financing, where the users pay for the cost of the service. To accomplish this, rates will periodically have to increase following the cost of upgrading the plant as indicated in the 2020 waterworks assessment required by *The Water Regulations*, 2002.

The Town of Lampman is in the process of replacing the water treatment plant. The first step was completed: pre-design report. Additional land has been purchased and is in the process of being subdivided for the new proposed Water Treatment Plant. The pilot project is complete. The design phase is now underway, permits to be acquired, and grants will be applied for in the fall of 2025. The anticipated start date for construction will be spring of 2026.

WATERWORKS CAPITAL INVESTMENT STRATEGY

The objective of the waterworks capital investment strategy is to address anticipated waterworks infrastructure maintenance, the immediate drinking water infrastructure problems and future infrastructure replacements in a timely fashion so as to ensure the municipal waterworks provides safe drinking water to residents and businesses. The strategy uses the 2020 waterworks system assessment that was required by Saskatchewan Environment for infrastructure planning.

This capital investment strategy will ensure that safe drinking water can be provided to the residents and businesses in the community in the present and future.
